

**Habif, Arogetti & Wynne, LLP Raining Refunds Sweepstakes  
Official Sweepstakes Rules**

These Official Sweepstakes Rules apply to Habif, Arogetti & Wynne, LLP's Raining Refunds Sweepstakes to be held from March 15, 2013 through May 1, 2013 (the "Sweepstakes"). This Sweepstakes is sponsored by Habif, Arogetti & Wynne, LLP, Five Concourse Parkway, Suite 1000, Atlanta, Georgia 30328 ("HAW" or "Sponsor").

**Prize:** The Sponsor will award one Grand Prize. The single Grand Prize will consist of \$500.00 in cash or in check or other bank/financial institution instrument available for immediate negotiation. Odds of winning the Grand Prize depend on the number of eligible entries, and only one (1) Grand Prize will be awarded.

Payment of any and all taxes associated with the Grand Prize is the responsibility of the winner of the prize. The Grand Prize may not be transferred, assigned, exchanged, or refunded.

The acceptance of a posting of an actual score will constitute a single entry. All such entries must be made between March 15, 2013 and before 12:00 midnight EST on May 1, 2013. No paper, mechanical or other reproductions or photocopies of entry forms will be accepted. One entry per person. All entries become the property of HAW and will not be returned. The winner will be notified by telephone, e-mail, mail, or other method, all at Sponsor's sole discretion.
